2. Curriculum

- Courses are categorized into two main types: **required courses**, which must be completed, and **elective courses**, which students can choose to take. These courses are further divided into different areas:

- General Education Courses (Common General Education, Balanced General Education, General Electives)
- Major Courses (Required Major Courses, Elective Major Courses, Approved Major Courses)
- Teaching Profession Courses (Some departments may not have required major courses.)

a. Credits

- 1) The criteria are based on the class hours of each course.
- 2) Credits are assigned per course, and if a student does not achieve a certain grade in a

course, they are disqualified, and the disqualified course will not count toward the earned credits.

Classification	Details
0 Credits	Courses such as chapel and graduation thesis do not carry credits; however, students must receive a Pass (P grade) in required courses to graduate.
1 Credits	For a theory class that meets for 1 hour per week or a practical class that meets for 2 hours per week during one semester.
2 Credits	For a theory class that meets for 2 hours per week or a practical class that meets for 4 hours per week during one semester. Note: In the arts and physical education fields, a practical class that meets for 3 hours per week may also be counted as 2 credits.
3 Credits	For a theory class that meets for 3 hours per week or a practical class that meets for 6 hours per week during one semester. Note: In the arts and physical education fields, a practical class that meets for 4 hours per week may be counted as 3 credits; in practical music, a class that meets for 3 hours (2 hours lecture + 1 hour practice) may also count as 3 credits.

※ Additional Notes:

- Depending on the curriculum, there may be courses that deviate from the above credit criteria.

- To complete the standard curriculum, students must undergo 8 semesters over 4 years (the medical school program consists of 4 semesters for pre-medicine, 8 semesters for medicine, the architecture program is 5 years or 10 semesters, and the pharmacy program is 6 years or 12 semesters).

- Students must meet the graduation requirements established by their respective departments.

b. General Education Curriculum

- 1) The general education courses are divided into common general education, balanced general education, and general electives. The completion criteria vary by year of admission as follows:

※ All common general education courses for students affiliated with KAC College are conducted in English through face-to-face classes.

※ Courses such as Military Studies and Lifelong Education are subjects that applicable students must complete and are included in graduation credits.

※ All common general education courses for students belonging to KAC College are conducted in-person in English.

※ The courses AI and Computational Thinking (1 credit, 1st year) and Introduction to Smart

Business and Entrepreneurship (2 credits, 2nd year) are mandatory for students admitted from the 2022 academic year onward.

※ Courses such as Military Studies and Lifelong Education are for relevant students and are included in the graduation credits.

★ Transitional Measures Following the Reformation of the General Education Curriculum for the 2024 Academic Year

- ▶ Students Admitted Before the 2013 Academic Year:
Must complete a total of 30 credits, including common general education, balanced general education, area-specific general education, and general education, without repeating the same course, including Chapel (1) and Chapel (2).

- ▶ Students Admitted from the 2014 to 2023 Academic Years:
Transitional Measures for Common General Education Completion:
Must complete a total of 12 credits, including Chapel (1) and Chapel (2), without repeating the same course.
Transitional Measures for Balanced General Education Completion:
 - a. Students admitted from the 2014 academic year to the 2023 academic year must complete at least 3 credits (a total of 15 credits) in 5 out of the 6 designated areas.
 - b. Students from the College of Fine Arts (2023 Academic Year Admitted): Must complete at least 3 credits (a total of 6 credits) in 2 areas among Literature and Arts, Global Leadership, and Career Exploration/Self-Development/Entrepreneurship.
 - c. If there are specific completion criteria set, those regulations and rules should be followed:
 - 1) College of Humanities and International Studies (Students admitted from 2017 to 2019 under the CORE Project): Follow the "Regulations for Strengthening Keimyung Humanities Competencies."
 - 2) College of Nursing: Follow the "Academic Regulations for the College of Nursing."
 - 3) Keimyung Adams College: Follow the "Academic Regulations for Keimyung Adams College."

c. Major Curriculum

- 1) Major subjects consist of required, elective, and recognized subjects, and all subjects designated as required must be completed.
- 2) The structure of the major curriculum is as follows:

Curriculum Structure	Detailed Description
Major Basics	Courses designed to acquire foundational (beginner level) theories and knowledge necessary for completing the major curriculum.
Major General	Courses aimed at acquiring in-depth (intermediate level) theories and knowledge related to general fields and topics in the major.
Major Advanced	Courses offered to provide a foundation for professional growth through in-depth (advanced level) theories and knowledge related to specific fields and topics in the major.

★ Transitional Measures for the Revision of the Major Curriculum for the Academic Year 2024

▶ Starting from the 2024 academic year, the classification of major foundation courses will be abolished (courses will be eliminated and converted to major electives and requirements). Therefore, students do not need to complete courses that were classified as major foundation up to the 2023 academic year.

c. Major Curriculum: Not applicable.

3. Double Majors/Interdisciplinary Majors

a. Double Majors

- 1) Eligibility for Completion: Students with a recognized academic period of 3 semesters or more.

2) Application for Completion: Applications must be submitted through the EDWARD system within 60 days from the start of each semester.

3) Restrictions on Completion

a) Double Major

Students in the pre-medical course, medical course, nursing course, architecture course (5-year program), pharmacy college, and Keimyung Adams College are not allowed to double major (however, it is possible to double major within departments of Keimyung Adams College).

Students in discontinued programs cannot apply for a double major in principle.

b) Minor: Students in the pre-medical course, medical course, nursing course, architecture course (5-year program), and pharmacy college.

4) Completion Requirements

a) Double Major

- Students must earn at least 42 credits (including required courses) in the major subjects of the department they wish to double major in.
- If the department requires a graduation thesis as a graduation requirement, it must be completed.

b) Minor

- Students must earn 54 credits (including required courses) in their major subjects and at least 21 credits in the major subjects of the department they wish to minor in.
- Students who wish to pursue multiple minors must earn 42 credits in their major subjects and at least 21 credits in the major subjects of each department they wish to minor in.

b. Microdegree

1) Microdegree refers to completing a specialized curriculum that is the minimum unit for cultivating future talents equipped with interdisciplinary capabilities to respond to changing social demands and educational environments.

2) Application and Withdrawal

a) The eligibility for applying for a microdegree is generally limited to students who have completed at least 2 semesters (for transfer students, at least 1 semester).

b) Applications must be submitted through the EDWARD system within 60 days from the start of each semester. However, students registered under the credit registration system and time registration system will have separate regulations.

c) Students who wish to withdraw from the microdegree must apply through the EDWARD system within 60 days from the start of each semester.

3) Method of Completion

a) Students must complete the specified credits for each microdegree curriculum.

b) Microdegrees offered in the first major cannot be pursued.

- c) Courses completed as part of the microdegree will be recognized as courses in other majors, and if the courses from the first major and the microdegree program are the same, they will be recognized as courses in the first major. However, if a request is made to change the course classification, it may be recognized as a course in the department (major) offering the microdegree program, but it will not be recognized as overlapping with the first major.
 - d) Courses completed before applying for the microdegree will also be recognized as credits for the microdegree.
 - e) Students who have completed the microdegree will not receive the microdegree if they meet the requirements for double majoring or minoring in the respective department (major) and interdisciplinary major.
- 4) Completion Notation: If the graduation requirements are met and the microdegree is completed, the name of the completed microdegree will be indicated on the diploma.

c . Interdisciplinary Major

- 1) An interdisciplinary major refers to a virtual major operated by multiple departments (majors) in addition to the first major. It aims to develop creative competencies through the integration of knowledge across disciplines, reflecting the potential for new approaches to academic inquiry and the creation of new professions in the curriculum.
- 2) Application and Withdrawal
 - a) The eligibility for application to the interdisciplinary major is generally restricted to students who have completed at least three semesters.
 - b) Applications must be submitted within a specified period of 60 days from the start of each semester via the EDWARD system.
- 3) Operation and Completion Methods
 - a) The interdisciplinary major operates exclusively as a double major or minor; it cannot be completed as a standalone major.
 - b) If a student chooses to pursue a double major in a department (major) that requires experiments, practical training, or hands-on work, additional fees for experiments and practical training may be charged accordingly.

* If a student completes an interdisciplinary major as a double major or minor, any overlapping courses between the interdisciplinary major and the first major will be recognized only as part of the first major. However, in the case of a double major, up to 6 credits may be recognized as courses from the interdisciplinary major (subject to a change in course classification). Courses completed before the establishment of the interdisciplinary major will not be recognized.

4. Course Registration

a. **수강꾸러미(Course Package System)**: This system allows students to pre-register for courses offered in the semester, helping them understand the credits they have earned and the credits needed for graduation. It facilitates course registration by linking it to the actual registration process. Courses that meet the conditions will be automatically registered, enabling students to thoroughly review their class plans in advance.

2) Notes

a) Just because courses (subjects) are included in the course package does not mean that course registration is complete, so it is essential to verify whether the course registration has been reflected.

b) Subjects that are not reflected in the course registration from the course package must be registered by the student on the designated registration date set by the respective college.

c) Remote classes cannot be registered multiple times if they are in the same category as indicated during the class time.

b. Course Registration

1) Course Registration Period: Refer to the academic calendar

2) Course Registration Location: Anywhere with an internet-connected PC

3) Course Registration Method: Log in to the course registration system (<https://sugang.kmu.ac.kr>) (Course registration is on a first-come, first-served basis)

4) Course Registration Information Site: School homepage → EDWARD Portal (<https://portal.kmu.ac.kr>)

- a) View Class Schedule: EDWARD system → Academic Administration → Classes → Course Registration Management → View Class Schedule
- b) View Class Schedule Changes: EDWARD system → Academic Administration → Classes → Course Registration Management → View Class Schedule Changes
- c) View Permanent Grades: EDWARD system → Academic Administration → Grades → Grade Processing → View Permanent Grades
- d) Check Course Registration Details: EDWARD system → Academic Administration → Classes → Course Registration Management → Check Course Registration

5) Course Registration

a) Course registration is conducted on a first-come, first-served basis if there are available seats.

b) When accessing the course registration system with the initial password, the screen will switch to the password change screen, so please click the "Forgot/Change Password" button to change your password in advance.

c) Password Change Method: ① Log in with your ID (student number) + initial password (6-digit birthdate) → ② Proceed with identity verification and authentication process, then change your password → ③ Log in with the new password → ④ Confirm personal information agreement (guidance and agreement regarding the collection/use/provision of personal information).

d) Students must decide which courses they wish to take and register for those courses themselves. However, for first-year students (new students of the current year), required courses will be registered collectively by the Academic Affairs and Teaching Team, **and these courses cannot be changed.**

(1) Courses Registered Collectively: Common Education, First-Year Major Required Courses

(2) Courses Other Than Those Registered Collectively: For major electives and general education courses excluding common education, students must register during the course registration period or the course adjustment period.

(3) **Check Courses Registered Collectively: This can be confirmed in the EDWARD system.**

(4) Menu: **EDWARD System → Academic Administration → Classes → Course Registration Management → Print Course Confirmation**

e) After course registration, the instructor may change due to school or individual faculty circumstances.

f) The Center for Teaching and Learning Development allows students to take up to 2 remote courses (6 credits) (excluding common education remote courses): If the remote courses have the same section as indicated in the schedule, duplicate registrations will not be allowed.

g) Allowed credits for course registration

(1) (Students admitted from 2024 academic year) cannot register for more than 18

credits per semester and 34 credits per academic year. However, students from the College of Education, Nursing, and Architecture may not exceed 20 credits per semester and 36 credits per academic year. Students in the Medicine, Pharmacy, and Pharmaceutical Sciences programs may not exceed 24 credits per semester, while students in the Pre-Medicine program may not exceed 21 credits per semester (the academic year is defined by the number of registrations: 1–2 times, 3–4 times, 5–6 times, 7–8 times for each respective academic year).

- (2) (Students admitted in the 2023 academic year and before) A maximum of 20 credits per semester and 36 credits per academic year can be registered. However, exceptions apply in the following cases:
- (3) Students with a GPA (including F grades and failed courses) of 4.25 or higher in the previous semester may register for up to 3 additional credits in the following semester. However, this does not apply to students in the pre-med, medical, architecture, pharmacy, and pharmaceutical science programs.
- (4) Pre-med students may take a maximum of 21 credits per semester.
- (5) Medical, pharmacy, and pharmaceutical science students may take a maximum of 24 credits per semester.
- (6) KMU-DIT dual degree program students may register for credits as follows during their 2.5 years at our university: 18 credits in the first semester and 22 credits in the remaining four semesters.
- (7) Students at the Keimyung Chopin Music Institute of the College of Music and Performing Arts may take a maximum of 21 credits per semester.
- (0) If the course you wish to register for exceeds the allowed number of students, you will not be able to enroll and must choose another course. Therefore, you should enter your course selection as quickly as possible at the start time of registration to secure your desired course (first-come, first-served).
- (ㄷ) If the instructor of the course you wish to take is a parent, it is advisable to avoid taking that course and to select a different one.
- (ㄹ) Students who have achieved academic excellence in the semester must comply with Article 3 (Academic Excellence Students) of the Scholarship Regulations Implementation Guidelines, which stipulates that they must earn at least 15 credits in the previous semester without failing any courses. Selections are made based on the average GPA and certified foreign language scores. [Inquiries: Scholarship and Welfare Team, 580-6093]
- (ㄱ) Regarding retaking courses
- (1) A course may be retaken only if the course number or name is identical and the earned grade is C+ or lower (including F grades). Retakes are allowed up to two times during enrollment (instances of retaking and receiving an F grade do not count toward this limit).
- (2) The higher grade earned from the retake and the previous grade will be

reflected in the GPA, and in cases where the grades are the same, the most recent grade will be considered. This principle also applies to courses where the credits or classification have changed.

(3) The grade for a retaken course may not exceed an A0.

(4) Courses that are retaken but not reflected in the GPA will be marked as 'R (Retake)' and will not count towards earned credits.

(5) If the course you wish to retake has been discontinued, you cannot retake it.

(6) However, if the course has been discontinued and the earned grade is C+ or lower (including F grades), students who are in their expected graduation semester (8 semesters or more) may forfeit credits for that course up to a total of 6 credits during their enrollment period, and the course will be marked as 'W (Withdraw).'

(7) Issuance of transcripts: All courses taken and earned (including courses with F grades) will be displayed on the transcript. Please refer to the school website → Student Life → Academic Information → Transcript Issuance Guide (methods for issuing transcripts).

(8) Before the start of each semester (in January and July), students must check the school website for announcements regarding course registration.

c. Course Change: During the course adjustment period, students can register for newly offered courses, change courses that were registered during the registration period, enroll in courses with increased enrollment limits, register for remote classes, and register for courses with available seats.

d. Course Withdrawal: If it is determined that a registered course cannot be continued, students may withdraw from the course they have already registered for in that semester (removal is not possible after the specified period).

(1) Withdrawal Period: To be announced on the school website.

(2) Courses that are withdrawn from will be included in the annual allowable credits.

(3) First-year students cannot withdraw from the common liberal arts courses that were registered for collectively.

5. Electronic Attendance System

a. Electronic Attendance System: An automatic attendance processing system utilizing mobile (app) and Bluetooth methods.

b. Essential Requirements for Mobile (App) Based Electronic Attendance:

Installation of the smart electronic attendance mobile (app) and Bluetooth functionality is required (network is not necessary).

How to Install the Electronic Attendance System Mobile (App):

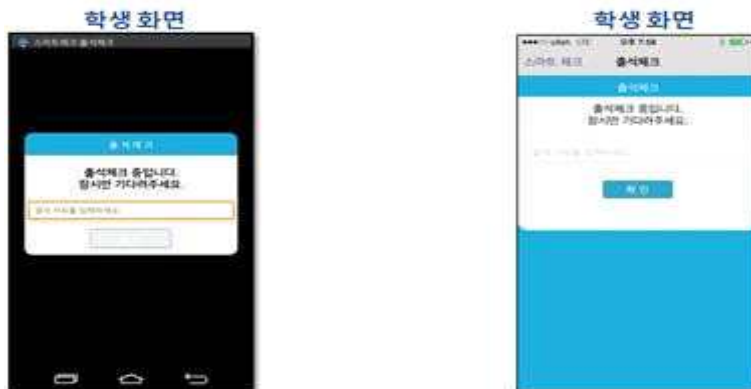
For Android: Search for "계명대학교 전자출결" in the Play Store and install.

For iPhone (iOS): Search for "계명대학교 전자출결" in the App Store and install.

c. How to do 'Attendance Checking'

1. Before entering class, install the electronic attendance app on your smartphone.
2. Log in to the electronic attendance app and check whether you have been automatically marked present according to the professor's electronic attendance check via your smartphone.
 - When the professor clicks the [Start Attendance Check] button, a PUSH message will be sent to the students, and attendance will be automatically checked through Bluetooth between the professor's phone and the students' phones for 30 seconds.
 - iPhone (iOS) users need to slide the smartphone screen in response to the received PUSH message (this does not apply to Android).
 - If an attendance error occurs, immediately request the professor to correct the attendance processing during class.

6. Grades

a. Grade Evaluation: The grading for each course is determined by the course instructor, who evaluates students based on a comprehensive assessment of exam scores, assignments, attendance, and learning attitudes (please refer to the grading criteria outlined in the syllabus)

1) Grading Criteria

- a) The grades for special courses such as experiments, practical training, field training, or equivalent courses, as well as for students with early employment, may be evaluated using separate methods.
- b) If a student is absent for more than 1/3 of the total class hours in a semester (1/2 for student-athletes), their grade for the course will be marked as a fail (F).

d) The GPA (Grade Point Average) is calculated as follows:

GPA = (Sum of (Grade Points × Credit Hours) for each course) / Total Credit Hours Registered. However, credits for courses that were dropped are excluded from the GPA calculation.

b. Grade Warning and Dismissal Warning

- 1) Grade Warning: A student receives an academic warning if their GPA for the semester falls below 1.50 (for pre-med students, the threshold is 2.00). However, students in their final semester (8th semester or beyond) are exempt from receiving an academic warning.
- 2) Dismissal Warning: A student is dismissed if they receive academic warnings for three consecutive semesters during their time in school. For pre-med students, dismissal occurs after two warnings. For medical, pharmacy, and pharmaceutical science students, up to four warnings are allowed, after which dismissal occurs if exceeded.

c. Grade Adjustment for Certification Acquisition (School Homepage→Student Life→Academic Guide)

- 1) Credits can only be adjusted if the student has taken the relevant course and obtained a certification (or official test score) afterward.
- 2) Credit Adjustment Application: Access EDWARD System → Academic Administration → COMpass K (For detailed information, refer to the attached file) → COMpass K Records → Personal COMpass K Record Entry → Certifications → Enter Information → Click "Apply for Credits" → Print the Credit Adjustment Application → Submit the application form and original certification to the administrative office of your department (from the start of classes until the regular exam period ends).
- 3) Only foreign students can apply for credit adjustments with the Korean Language Proficiency Test (TOPIK). Korean students cannot use this test for credit adjustment.
- 4) The criteria for credit adjustments based on certifications can be found on the university website → Student Life → Academic Guide.

7. Academic Status Changes

- a. Leave of Absence [EDWARD System → Academic Affairs → Academic Records → Academic

Status Change Management → Academic Status Change Application (Leave of Absence)]

1) General Information

- a) Leave of Absence Without Registration: Application submission period is until 1/4 of the class days (not available for new students).
- b) Leave of Absence After Registration: Available from the start of regular registration for the semester until the beginning of the final exam period for that semester.
- c) Duration of Leave: General leave of absence can be taken for up to 1 year (2 semesters) per request, and the total period cannot exceed 3 years.
- d) Restriction for First-Semester Freshmen: Freshmen cannot apply for leave during their first semester except for medical or military service reasons.
- e) Scholarship Eligibility: Scholarships are valid only for the applicable semester. If a scholarship student takes leave without registering, the scholarship is forfeited.

2) Personal Leave (can be applied through EDWARD System)

- a) Before 1/3 of the Class Days: Full tuition credit is granted.
- b) From 1/3 to 1/2 of the Class Days: Half of the tuition is credited.
- c) After 1/2 of the Class Days: Tuition is forfeited.

3) Military Service Leave (can be applied through the EDWARD System - scan and attach the enlistment notice)

- a) Application Period: Leave for military service should be applied for between two weeks prior to the enlistment date and the enlistment date itself.
- b) Before 2/3 of the Class Days: Full tuition credit is granted for those who apply before this point.
- c) From 2/3 of the Class Days Until Before the End of Regular Exams:
 - **If wishing to earn credits:** Tuition will be forfeited. Students who wish to receive credit must apply for military service leave through the EDWARD system, print the application, confirm the course name, credits, and instructor, and then visit the academic affairs team to submit the application. If the instructor is not confirmed, the course grade will be recorded as F.
 - **If not wishing to earn credits:** Full tuition credit is granted.
- d) Mandatory Service for Officers: The three years of mandatory service will be recognized as military service leave.

4) Extension of Leave

- a) Extension of Personal Leave: This can be applied for through the EDWARD system.
- b) Students wishing to extend personal leave after military discharge must first apply for readmission through the EDWARD system, and once approved, they should then apply for personal leave through the EDWARD system.
- c) For students who need to switch to personal leave after the readmission period has passed following military discharge, they must visit the academic affairs team (Room 202, Haengso Hall) to submit the leave extension application along with the discharge

certificate.

5) Extension of Military Leave (for students serving as noncommissioned officers): Students must visit the academic affairs team (Room 202, Haengso Hall) with the leave extension application and a service verification certificate attached to apply.

※ The military leave period due to mandatory service is within 3 years. If the service period exceeds this, students can submit a service verification certificate to extend the leave for an additional 2 years.

6) Leave of Absence for Medical Reasons, Childbirth, Childcare, National Exam Training, and Entrepreneurship: Students must visit the academic affairs team (Room 202, Haengso Hall) with the leave application and relevant supporting documents attached to apply.

a) Medical Leave: Medical certificate from a general hospital with a recommendation for at least one month of rest.

b) Childbirth Leave: Birth certificate or expected birth certificate.

c) Childcare Leave: A copy of the resident registration certificate.

d) National Exam Training Leave: Certificate of training from the training institution.

e) Entrepreneurship Leave: Business registration certificate and business plan (must be related to the student's major – apply through the Startup Education Center).

* For inquiries about entrepreneurship leave: Startup Education Center (580-6772)

[Eligibility for Entrepreneurship Leave]

Students who have been operating a business for at least 30 days before applying and have completed at least two semesters can apply for entrepreneurship leave if they meet one of the following criteria:

Awarded in a startup-related competition or contest.

Selected for a startup support program by a government agency.

Currently participating in a startup incubation or education program lasting two months or more.

Completed at least one course in a startup-related subject.

A business generating revenue through startup activities.

[Application Deadline]: Leave application must be submitted by the end of the course registration period.

7) Return Notification: Students who take a leave of absence for military enlistment and are sent back home after their physical examination or other reasons must report their return to the Academic Affairs Team (Room 202, Haengso Hall) within 10 days.

8) Cancellation of Leave of Absence:

a) Seongseo Campus: Visit your college's administrative team and the Academic Affairs Team (Room 202, Haengso Hall) for application.

b) Daemyung Campus: Visit your college's administrative team for application.

9) Important Notes for General Leave of Absence Before Military Enlistment:

a) Even after taking a leave of absence, if you do not apply for military enlistment

through the Military Manpower Administration, your enlistment will be delayed.

b) If you take a leave of absence without a confirmed enlistment date, it may lead to a long wait for enlistment, which could disrupt your future plans, including the timing of your return and readmission after discharge.

b. Reinstatement [EDWARD System → Academic Administration → Academic Status → Manage Academic Status Changes → Apply for Reinstatement]

1) General Information:

Students on leave of absence must apply for reinstatement through the EDWARD system during the reinstatement application period each semester (1st: January, July / 2nd: February, August) when their leave period expires or the reason for their leave ends.

※ **Students who took a leave after completing their first or second semester of the first year and wish to apply for a teaching certificate must return to school by the 1st semester of the second year (3rd semester) and apply for the certificate in the first week of March. (For inquiries: Academic Affairs and Faculty Team ☎ 053-580-6009)**

2) Military Leave of Absence:

Apply through the EDWARD system [Scan and submit one of the following: discharge certificate, resident registration certificate with discharge date, or expected discharge certificate].

3) General Leave of Absence:

Apply through the EDWARD system (no additional documents required).

4) Medical Leave of Absence:

Submit the reinstatement application and a health certificate (from a general hospital) to the Academic Affairs and Faculty Team (Room 202, Haengso Hall) in person.

b. Early Graduation: A system that allows academically outstanding students to shorten their study period and graduate early.

1) Eligibility

a) Students who have registered for 6 semesters or more, earned at least 130 credits, and have a cumulative GPA of 4.25 or higher (including credits for courses dropped) are eligible to meet graduation requirements.

b) Students with any F grades are not eligible to apply (including grades for the expected graduation semester).

2) Target Group: All students except those in the College of Medicine, Architecture (5-year program), Pharmacy, Pharmaceutical Science, transfer students, and readmitted students.

3) Application Procedure: Students wishing to graduate early must apply through the EDWARD system within 30 days after the start of the expected graduation semester.

C. Graduation thesis

- Graduation papers can be passed through the graduation exam if they do not meet the exemption criteria below.

c. Scholarship System (Scholarship and Welfare Team)

- 1) To receive scholarships, you must register your main bank account number in your name (EDWARD system → Common → System Common → Environment Settings → Modify Personal Information).
- 2) Students selected as Academic Excellence Scholars or Keimyung Happiness Scholars must complete 10 hours of volunteer work each semester.
- 3) When selecting Academic Excellence Scholars each semester, the selection is based on 70% of the previous semester's grades and 30% of the official foreign language test score obtained within the last two years.
- 4) Payment Method: Scholarships are generally deducted from tuition fees each semester.
- 5) On-campus and off-campus scholarships can be received in combination within the tuition limits, but exceeding this limit is not allowed.
- 6) You can combine scholarships for on-campus and off-campus work, volunteer activities, and other conditional scholarships, as well as expense scholarships (such as for overseas study, exchange students, book fees, dormitory fees, etc.), one-time awards, living expense support, and study incentive scholarships as defined separately by the president.
